Course Syllabus

Course Description:

A study of character development, acting styles and improvisation, with an introduction to children's theater, cross-disciplinary presentations and experience in theatrical performance. This is an intermediate level skills class with a limited performance requirement. This course will challenge students through the development of stock characters, the performance and critique of theatrical performances, theatrical outreach, children's theatre basics, and hands-on experience developing and delivering educational presentations with the goal of preparing students to utilize their developed artistic skills beyond the classroom. This full-year course addresses National Core and California State Standards for grades nine through twelve through a Biblical lens. The course may require one evening rehearsal and one evening performance per year. Prerequisites: completion of TA I with a C or better or approval from the instructor.

Curricular Mapping:

This class builds on the foundational skills learned in Theatre Arts I by providing intermediate skills training in acting and improvisation, strict adherence to due dates and an increased accountability to peers. These skills are crucial to both success in college level academic pursuits and to performance standards in the professional industry of theatre.

Course Objectives:

Upon the successful completion of this course the student will be able to:

1. Critique a performance.
2. Use grade level appropriate vocabulary to discuss aspects of theatre.
3. Perform rehearsed works for an audience.
4. Demonstrate knowledge of the techniques used in Children's Theatre Ministry.
5. Demonstrate knowledge of grade level appropriate aspects of theatre history.

Texts:

Prerequisites:

Successful completion of VIPA 1628 or special permission from the instructor. *If a student petitions to take Theatre Arts II prior to completing the prerequisite class, that student will need*

*to accomplish the following: provide proof of completion of an equivalent class at another school or conservatory or successfully complete an interview and assessment with the instructor.*

Course Outline and Requirements:

This course is an intermediate level Theatre Arts class. The course will focus primarily on advanced character development and children’s theatre. It will include advanced instruction in improvisation through various in-class exercises and games, in-depth character analysis, performance critiques and both public and in-class performances of monologues and scenes.

Due to the participatory nature of the class, a daily participation grade will apply. In addition to participation, students will be required to complete the following assignments:

1. Complete character development reports.
2. Complete performance critiques and character analysis worksheets.
3. Perform memorized theatrical works.
4. Design and deliver a presentation.
5. Develop a children’s theatre program proposal.
6. Participate in theatrical outreach to local elementary schools.

Participation	30%		

1. **Participation** = 30 %
  - a. 5 points per day
  - b. Participation points can be made up for excused/extended absences. An additional assignment will be given upon request on a case by case basis.
  - c. Extended absences must be pre-approved through a signed Advance Absence Request form (available in Student Services) to qualify for makeup work.
2. **Performance** = 35%
3. **Assignments** = 35%
4. **Late Work** – This class requires group participation. Most assignments affect additional students. For this reason, late work may be assessed a penalty of 10% per day for major assignments and a flat 50% for minor assignments. Late penalties will be assessed at the discretion of the instructor.

5. **On Task Work** – When time is given in-class to work on assignments, the student is expected to be on-task. When students are off-task (e.g. playing games, messaging, working on other courses, etc.), the instructor has the discretion to deduct points from the assignment’s total point value, up to 50%
6. **Homework Expectations** – For work requiring an outside of class commitment the following will apply:
  - a. Small projects = up to two hours.
  - b. Theatre Appreciation Paper = up to two hours over a period of one to two weeks.
  - c. Memorization of lines = dependent on the student. In most cases, at least one to two weeks are allowed for small roles and up to one month is allowed for large roles.
  - d. Interpretive Presentation = 5-10 hours. For this project, a minimum of two to three weeks is allowed for creation. Some work is done in class.

Class Policies:

**Attendance** – In-class participation on a daily basis is crucial in acting. Not only does absence affect the individual student, it affects the class as a whole. Therefore, this class includes a daily participation grade.

**Tardiness** – Tardiness slows down the progress of the class as a whole and puts the tardy student at a disadvantage. Students must be in class and ready to work when the bell rings. Tardies will be tallied and reported according to Monte Vista policy.

**Additional Guidelines**

1. Students are expected to be respectful to faculty, staff, and fellow students at all times.
2. Students are not allowed in the Theatre Arts woodshed or technical booth unless specifically assigned to a duty in one of the aforementioned areas.
3. Failure to follow the aforementioned guidelines will result in disciplinary action.

School Policies and Expected Student Learning Results (ESLRs):

Furthermore, it is each student’s responsibility to read and follow all academic policies of Monte Vista Christian School. In addition to addressing each ESLR every year, we target a specific ESLR each academic year for particular focus.

2. Communicate with the instructor. Advance notification of absences and other issues is the best way to assure your work will receive full credit.

3. Be willing to participate and try new things. Acting is more fun when you are not worried about what people think.
